


ASSET ALLOCATION (as at 30/11/2025)




CURRENCY BREAKDOWN (as at 30/11/2025)





INVESTMENT OBJECTIVE



The risk profile of this strategy is Medium/High. The choice of investments will not be limited by geographical area, economic sector or currency and investments are made with no reference to a market index. The fund is likely to hold 25-40 equities at any given time.

- Management's track record


